NOTIFICATION

No. SOR-III(S&GAD)1-9/2002. In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the Punjab Agriculture Department (Research Wing) Service Rules, 1980, the following amendments shall be made:

AMENDMENTS

In the said rules, in the Schedule, at Sr. No. 1.a) – Director Agriculture (Research):

- (1) in column No.4, for the existing entry, the following shall be substituted:

"Chief Minister"; and

- (2) in column No.7, for the existing entry, the following shall be substituted:

"By selection on merit from amongst officers in BS-18+Rs.165/SP working in the Research Wing as Deputy Director (Research), Deputy Director (Training), Agricultural Chemist, Soil Fertility Officer, Associate Agricultural Chemist, Soil Bacteriologist, Agricultural Technologist, Entomologist, Plant Pathologist, Plant Virologist, Plant Physiologist, Agronomist, Horticulturist, Botanist, Associate Botanist or Agricultural Economist having twelve years' services in BS-17 and above. In case the initial recruitment was made in BS-18+Rs.165/SP, seven years' service in BS-18+Rs.165/SP."
