- 2. The bid should be accomplished by 2% bid security of the estimated price in the form of CDR (refundable). The bid containing less bid security will not be entertained.
- 3. Bidding shall be conducted through open competitive Bidding Single Stage- One Envelope Procedure as specified in the Punjab Procurement Rules-2014 (as amended to date) and is open to all eligible bidders as defined in the bidding document.
- 4. Sealed bids must be delivered to the above office on or before Friday, 8th July, 2022 at 11:00 A.M. Proposals must be accompanied by a Bid Security as mentioned in bidding documents in the form of CDR duly issued from a Scheduled Bank of Pakistan.
- 5. Bids will be opened on Friday, 8th July, 2022 at 11:30 A.M. in the presence of bidders or their representatives at Wheat Research Institute, AARI, Faisalabad if bid closing/opening date falls on local/National holiday, the date of bid closing/opening shall be the next working day on the same time and venue.
- 6. The bidders are required to give their best and final prices as no negotiations are expected.
- 7. Bids not complying with the requirements shall be rejected being non-responsive. Alternate proposals and /or conditional bids shall be considered non-responsive.
- 8. Taxes will be deducted as per applicable government rules. NTN and sales Tax registration certificate must be provided with the bid.
- 9. Bids which are incomplete, not sealed, not signed and /or not stamped, late or submitted by other than specified mode will be rejected.
- 10. The contract shall be awarded to the lowest evaluated bidder.

- Bidding documents are available and may be purchased by any interested eligible bidder upon payment of Rs.1000/- in cash (Non-refundable) from the office of the undersigned on or before the last date of submission during office hours (9:00 AM to 5:00 PM) on any working day (Monday to Friday).
- 2. The undersigned will not be responsible for any expenses incurred by bidders in connection with preparation and delivery of bids. Alternative bids will not be considered.
- 3. Single stage one envelope bidding procedure shall be adopted as specified in the Punjab Procurement Rules-2014 (as amended to date).
- 4. The bids shall be quoted in Pak Rupees. The quote rate shall be valid up to 23.10.2022.
- 5. Each bid should be accomplished by 2% bid security of the estimated price in the form of CDR (refundable). The bid containing less bid security will not be entertained.
- 6. At any time prior to the deadline for submission of bids, the procuring agency whether at its own initiative or in response to a clarification by a prospective bidder, may modify bidding documents by amendment.
- 7. Copy of registration certificate of Income & Sales Tax should be provided along with offer.
- 8. Bids shall be signed by the bidder or a person or persons duly authorized on behalf of the bidder. Such authority will be indicated by written power of attorney accompanying the bid. The bid shall contain no interline action, erasures or overwriting except as necessary to correct errors made by the bidder, in such case correction shall be initialed by the person or persons signed the bid.
- 9. The original bid must be received by procuring agency in the office of the undersigned on or before 08-07-2022 by 11:00 A.M. Any bid received after the deadline will be rejected.

- 10. The bid will be opened on 08-07-2022 at 11:30 A.M by the purchase committee in the presence of the under signed and the bidders/representatives. The bidders shall sign the register evidencing their attendance.
- 11. The successful bidder will sign a procurement contract and complete the said work within 90 days of the issuance of work order. If the bidder fails to complete the said work within stipulated period the bid security will be forfeited.
- 12. It must be clearly written whether sales and other taxes are included in the quoted price or not, if not mentioned in the quotation it would be presumed that all taxes are included.
- 13. The procuring agency will examine the bids to determine whether they are complete, whether any computational errors have been furnished, whether the documents have been properly signed and are generally in order.
- 14. The procuring agency reserves the rights to reject all bids at any time prior to issuance of work order, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders.
