

The Chief Scientist, Wheat Research Institute, AARI, Faisalabad invites sealed bids for the purchase of Agriculture Fertilizer Front End Loader from firms registered with sale and income tax department and active tax payers.

#### **Terms and Conditions:**

1. Interested eligible bidders may obtain bidding documents (including specifications) immediately from Wheat Research Institute, AARI, Faisalabad during office hours after payment of PKR.100/-
2. The bid should be accomplished by 2% bid security of the estimated price in the form of CDR (refundable). The bid containing less bid security will not be entertained.
3. Bidding shall be conducted through open competitive Bidding Single Stage- One Envelope Procedure as specified in the Punjab Procurement Rules-2014 (as amended to date) and is open to all eligible bidders as defined in the bidding document.
4. Sealed bids must be delivered to the above office on or before **Friday, 8<sup>th</sup> July, 2022 at 11:00 A.M.** Proposals must be accompanied by a Bid Security as mentioned above in the form of CDR duly issued from a Scheduled Bank of Pakistan.
5. Bids will be opened on **Friday, 8<sup>th</sup> July, 2022 at 11:30 A.M.** in the presence of bidders or their representatives at Wheat Research Institute, AARI, Faisalabad if bid closing/opening date falls on local/National holiday, the date of bid closing/opening shall be the next working day on the same time and venue.
6. The bidders are required to give their best and final prices as no negotiations are expected.
7. Bids not complying with the requirements shall be rejected being non-responsive. Alternate proposals and /or conditional bids shall be considered non-responsive.
8. Taxes will be deducted as per applicable government rules. NTN and sales Tax registration certificate must be provided with the bid.
9. Bids which are incomplete, not sealed, not signed and /or not stamped, late or submitted by other than specified mode will be rejected.
10. The contract shall be awarded to the lowest evaluated bidder.

1. The undersigned will not be responsible for any expenses incurred by bidders in connection with preparation and delivery of bids. Alternative bids will not be considered.
2. Single stage one envelope bidding procedure shall be adopted as specified in the Punjab Procurement Rules-2014 (as amended to date).
3. The bids shall be quoted in Pak Rupees for Agriculture Fertilizer Front End Loader. The quote rate shall be valid up to 02.08.2022.
4. Each bid should be accomplished by 2% bid security of the estimated price in the form of CDR (refundable). The bid containing less bid security will not be entertained.
5. At any time prior to the deadline for submission of bids, the procuring agency whether at its own initiative or in response to a clarification by a prospective bidder, may modify bidding documents by amendment.
6. Copy of registration certificate of Income & Sales Tax should be provided along with offer.
7. Bids shall be signed by the bidder or a person or persons duly authorized on behalf of the bidder. Such authority will be indicated by written power of attorney accompanying the bid. The bid shall contain no interline action, erasures or overwriting except as necessary

to correct errors made by the bidder, in such case correction shall be initialed by the person or persons signed the bid.

8. The original bid must be received by procuring agency in the office of the undersigned on or before **08-07-2022 by 11.00 A.M.** Any bid received after the deadline will be rejected.
9. The bid will be opened on **08-07-2022 at 11.30 A.M** by the purchase committee in the presence of the under signed and the bidders/representatives. The bidders shall sign the register evidencing their attendance.
10. The successful bidder will sign a procurement contract and supply the Agriculture Fertilizer Front End Loader within 15 days of the issuance of supply order. If the bidder fails to supply the Agriculture Fertilizer Front End Loader within stipulated period the bid security will be forfeited.
11. It must be clearly written whether sales and other taxes are included in the quoted price or not, if not mentioned in the quotation it would be presumed that all taxes are included.
12. The procuring agency will examine the bids to determine whether they are complete, whether any computational errors have been furnished, whether the documents have been properly signed and are generally in order.
13. The procuring agency reserves the rights to reject all bids at any time prior to issuance of supply order, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders.
